MINIMUM- NIYOMTRONG VS. LANDERO FIGHT

WHEREAS, PANYA PROMOTION, legally represented by Mr Piyarat Vachirarattanawong, located at Thailand has requested official sanction for the WBA Minimum weight optional title defense between THAMMANOON NIYOMTRONG (NIYOMTRONG) (Champion) vs TOTO LANDERO (LANDERO) (N° 12), on March 6, 2018 in Chonburi, Thailand

WHEREAS, PANYA PROMOTION, has dy deliver all sanction requirements for the above-mentioned WBA Minimum weight title fight.

WHEREAS, THAMMANOON NIYOMTRONG last mandatory fight was on July 15, 2017 vs. RAY LORETO, whom he defeated by UD12..

WHEREAS, THAMMANOON NIYOMTRONG next mandatory title defense vs. MANDATORY CHALLENGER. BYRON ROJAS will be due on June 15, 2018.

WHEREAS, WBA Bylaws in Article C.30 among its faculties empowers the WBA Championship Committee to order elimination matches whenever necessary.

NOW, THEREFORE, IT BE RESOLVED, PANYA PROMOTION is authorized to promote WBA Minimum weight THAMMANOON NIYOMTRONG 's optional title defense vs. TOTO LANDERO (LANDERO) (N° 12), on March 6, 2018 in Chonburi, Thailand. With the following conditions:

- 1. Pursuant to WBA rule C.11- Title Defense Periods - champion must defend his title against the Official Contender or the leading available contender every nine (9).**
- 2. Pursuant to WBA rule C.13- Bout Limitations – the champion may not fight a boxer who is not the official challenger within sixty (60) days of the expiration of the mandatory defense period.**

*This committee is granting the **WINNER OF THE NIYOMTRONG VS. LANDERO FIGHT** a period of thirty (30) days to negotiate your upcoming mandatory fight against **BYRON ROJAS**, beginning March 7th, 2018 and will close at the end of the business day (- 5GMT) on April 7th, 2018.*

In the event an agreement is not reached, or if any of the parties, expresses unwillingness to negotiate the championship committee may call a purse bid.

The fight between the winner of Niyontrom vs Landero o Niyontrom in case of a DRAW must be scheduled before 60 days after an agreement has been reached.
