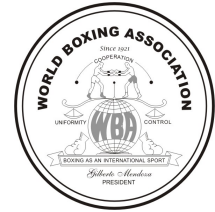

WORLD CHAMPIONSHIP COMMITTEE RESOLUTION N° 202110291102 WELTERWEIGHT October 29, 2021

WHEREAS TGB Promotions, legally represented by Tom Brown, located at 13273 Ventura Blvd #208 Studio City, CA 91604, USA has requested official sanction as WBA Welterweight title of the bout between Jamal James and Radzhab Butaev in Las Vegas, Nevada, USA on October 30, 2021.

WHEREAS Jamal James and Radzhab Butaev are eligible, physically fit, and officially licensed by their local boxing authorities.

WHEREAS WBA Bylaws in Article 6.04 among its faculties empowers the WBA Championship Committee to recognized championship matches throughout the world.

WHEREAS Each boxer, promoter, manager, and boxer's agent are under the obligation to know and be familiar with all Association rules. **WBA Rule C.14 Rule of familiarity.**

WHEREAS Registered Promoter who has requested or been granted sanction of a bout is responsible for payment of all sanction, promoter, and manager fees, and must submit documentation of payment to the Chairman, together with the formal application for the sanction of the fight and a copy of the contracts between the promoter and the boxers duly signed by them no later than thirty (30) days before the bout... Failure to comply with any of these requirements may result in non-sanction of the contest and removal of recognition of any boxer participating in the bout. **WBA Rule C.35 Fee Payment.**

TGB Promotions has not complied with a) Submission of the contracts duly signed by both boxers 30 days before the fight, b) Payment of the bout sanction fee.


WHEREAS All officials appointed by the President shall be protected by a policy for accidental death for the appointed bout, and Supervisors shall be covered by a life insurance policy against accidents while carrying out duties at a sanctioned fight. **WBA Rule C.39 Insurance.**

TGB Promotions has not provided the insurance certificate for the officials of the fight.

WHEREAS WBA Championship Committee to approve the bout subject that the winner must box (in his next fight) against WBA Super Champion Yordenis Ugas.

NOW, THEREFORE, IT BE RESOLVED TGB Promotions, is hereby requested to send the contracts of the fight duly signed by both fighters and pay the sanction fee today October 29, 2021, before the weigh in and rules reading ceremony takes place, otherwise the WBA will be forced to withdraw the sanction of the fight for the WBA Welterweight Championship between Jamal James and Radzhab Butaev next October 30, 2021, in Las Vegas, Nevada, USA.
